# **ORDINANCE NO. 24-04**

# AN ORDINANCE AMENDING COMPENSATION OF ELECTED VILLAGE OFFICIALS

WHEREAS, 65 ILCS/1-50-10 provides in relevant part that salaries of all officers who hold elective office shall be fixed by ordinance; and

WHEREAS, said salaries shall neither be increased nor diminished during the term of which they serve; and

WHEREAS, any new level of compensation shall be fixed at least 180 days of the beginning of the terns of the officers whose compensation is to be fixed; and

WHEREAS, the last time the salaries of Village Officers were increased was almost 10 years ago;

**NOW THEREFORE, BE IT ORDAINED,** by the President and Board of Trustees of The Village of Hodgkins the following:

#### Section 1

That Title 1, Chapter 5, Section 2B, Salary of Village President be amended by deleting the following: "fifty thousand dollars (\$50,000.00) and insert in lieu thereof the following: sixty thousand dollars (\$60,000.00)

#### Section 2

That Title 1, Chapter 6, Section 2A Trustee Compensation shall be amended by deleting the following: "twenty six thousand, four hundred dollars (\$26,400.00) an insert in lieu thereof the following: thirty six thousand four hundred dollars (\$36,400.00)

#### Section 3

That Title1, Chapter 7 section 1B Village Clerk Compensation shall be amended by deleting the following: "thirty two thousand dollars (\$32,000.00 and insert in lieu thereof the following: forty two thousand dollars (\$42,000.00).

### Section 4

If any action, paragraph, clause or provision of this Ordinance shall be held invalid the invalidity shall not affect other provisions of applications of this Ordinance.

## Section 6

All Ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed insofar as they conflict herewith.

#### Section 7

After this adoption and approval, this Amendment shall be in full force and effect beginning on March 11, 2024.
