ORDINANCE #24-08

AN ORDINANCE INCREASING THE WATER RATES TO HODGKINS CUSTOMERS

WHEREAS, the Village of Hodgkins ("Village') receives its water from the Village of McCook who charges, the Village \$5.95 per 1,000 gallons; and

WHEREAS, the Village charges a Senior rate of \$5.55 per 1,000 gallons with a minimum charge of 7,000 gallons = \$38.85

WHEREAS, the Village charges a Residential rate of \$7.94 per 1,000 gallons with a minimum charge of 7,000 gallons = \$55.58

WHEREAS, the Village charges a Commercial rate of \$10.44 per 1,000 gallons with a minimum charge of 14,000 gallons = \$146.16

WHEREAS, the Village charges a Three or more Residential Units of \$7.94 per 1,000 gallons plus the sum of \$1.10 per each residential unit with a minimum charge of 7,000 gallons

WHEREAS, the current hydrant meter minimum charge is \$125.00 and \$15.00 per 1,000 gallons

WHEREAS, the current wastewater service charge is .36¢ per 1,000 gallons, but in no case shall it be less than \$1.44 bi-monthly

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees for the Village of Hodgkins that the following amendment to the Village Code be adopted:

Section 1

The Senior Rate will now be an increase of \$.45 per 1,000 gallons to = \$6.00 per 1,000 gallons with a minimum charge of 7,000 gallons = \$42.00.

Section 2

The Residential Rate will now be an increase of \$.21 per 1,000 gallons to = \$8.15 per 1,000 gallons with a minimum charge of 7,000 gallons = \$57.05.

Section 3

The Commercial Rate will now be an increase of \$1.42 per 1,000 gallons to = \$11.86 per 1,000 gallons with a minimum charge of 14,000 gallons = \$166.04.

Section 4

The Three or more Residential Units rate will now be an increase of \$.21 per 1,000 gallons to = \$8.15 per 1,000 gallons and the unit will be \$1.10 per each residential unit with a minimum charge of 7,000 gallons

For the purpose of this section, every mobile home, flat, apartment, or separate living accommodation shall be considered a residential unit.

Section 5

The Hydrant Meter Rate will be a \$125 minimum charge and will be an increase of \$4.00 for \$19.00 per 1,000 gallons

Section 6

The Wastewater Services Charge will now be an increase of .04¢ per 1,000 gallons to .40¢ per 1,000 gallons, but in no case shall it be less than \$2.80 bi-monthly, for use of and for services supplies by the wastewater facilities of the Village

Section 7

If any action, paragraph, clause or provision of the Ordinance shall be held invalid, the invalidity shall not affect any of the other provisions of this Ordinance.

Section 8

All Ordinances or parts thereof in conflict with the provisions that are hereby repealed insofar as the conflict herewith.

Section 9

This Ordinance shall be in full force and effect from and after its adoption and approval. The Village Clerk is directed to publish this Ordinance in pamphlet form after its adoption.
