ORDINANCE NO. 24-11

AN ORDINANCE CREATING A NEW ZONING CLASSIFICATION

WHEREAS, the Hodgkins Public Library building was constructed on or around 1979 on five (5) lots; and

WHEREAS, in making plans for a replacement building it was discovered that of the five lots only one of the lots was properly zoned as "Public Lands"; and

WHEREAS, on September 24, 2024 the Hodgkins Zoning Committee convened to consider the reclassification of Lots 42, 76, 75 and 74 from "Residential" to "Public Lands"; and

WHEREAS, the Zoning Committee voted to recommend to the full Board of Trustees that the Lots cited above be rezoned to Public Lands;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees the following:

Section 1

Lots 42, 76, 75 and 74 are hereby reclassified from "R" Residential to "PUB" Public Lands.

Section 2

It is further ordered that the Village Engineer be directed to amend the VILLAGE OF HODGKINS, ILLININOIS ZONING MAP in accordance with this Ordinance 24-11.

Section 3

If any action, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity shall not affect any of the other provisions of this Ordinance.

Section 4

All Ordinances or parts thereof in conflict with the provisions that are hereby repealed insofar as the conflict herewith.

Section 5

This Ordinance shall be in full force and effect from and after its adoption and approval. The Village Clerk is directed to publish this Ordinance in pamphlet form after its adoption.
