Discussion regarding Special Events Permit.

There was a car show at Salerno's Restaurant a few weeks ago that created a lot of complaints. There was a meeting with the owner and management of Salerno's regarding the Car Show. This event was not only in the Salerno's parking lot, but spilled onto Village owned property and AMC owned property.

Mr. O'Connell will be creating a Special Events Permit for any future events that bring a large number of people.

Mayhem Car Shows will no longer be allowed to host car shows. The main complaint was noise.

The concern of the Village is liability when Village and AMC's property is being used without permission. Salerno's must include the Village of Hodgkins and AMC to be an additional insurer on their property for no less than \$1 million. The other issue is the noise from bands that play on the outdoor patio. Other towns give 1 permit for outside months for bands. There has been a suggestion an off duty officer be hired to help monitor special events. There were no washroom facilities brought in for the event. Event attendees were going into AMC to use their washroom, which in turn caused a complaint from AMC. There are rubber marks on the road from people driving aggressively when leaving the event. Concern for open liquor on Village and AMC property. Trustees suggested for large events Licensed Security be present or members of the Hodgkins Police Department.

Mr. O'Connell will be working on a Special Events Permit that will be presented at the next Board Meeting.

As for in town concern, there was a resident who hosted a wedding with a very loud band a few months ago and no neighbors or the Village were notified a head of time.

The Special Events permit would list the person's name and number so police had a contact person in case of complaints.
